

## Buyer Beware: The "Black-Tie Gala" Fundraising Dinner Provides Scant "Tax Deductible" Return on Admission Fees

- The RSVP form for the LHH Black-Tie Gala Fundraising Dinner indicates checks should be made payable to the Laguna Honda Volunteers, Inc., noting it is a "501(c)(3) non-profit," an IRS tax-exempt designation.
- The \$250 admission fee for an individual provides only \$50 as tax deductible; the \$350 ticket get a \$150 tax deduction.
- Why do the fees provide so little as tax deductible? Why the \$200 "overhead" per ticket?
