Dear Mr. Morewitz,

This is an Immediate Disclosure Request for public records under San Francisco's Sunshine Ordinance, the California Public Records Act, Proposition 59, and the Brown Act.

Please provide:

1. Any Resolution approved by the full health Commission authorizing DPH to issue an RFP to outsource and privatize dialysis services currently provided in Building 100 on SFGH's campus and re-locate those services to LHH. **There are no documents responsive to this request.**
2. Any meeting minutes of the full Health Commission in which it approved DPH's proposal to relocate SFGHs and DPH's dialysis services to LHH.
There are no documents responsive to this request. The issue was discussed by the SFGH JCC at its 2/14/12 and 4/10/12 open session meetings. I've included these minutes and relevant DPH presentations made at these meetings for your review. I have also included the 3/6/12 and 4/17/12 full Health Commission minutes in which Commissioner Chow, SFGH JCC Chair, updated the full Commission on the discussion of the DPH outpatient dialysis at the SFGH JCC meetings.
3. Any budget proposal "initiative" — on the appropriate B-1 budget initiative forms — in which DPH proposed to eliminate dialysis services currently provided on the SFGH campus.
There are no documents responsive to this request. No reductions have been made to the DPH outpatient dialysis budget.

Please note that DPH outpatient dialysis services located at SFGH are currently "outsourced" to UCSF. The recent RFP gave an opportunity for outpatient dialysis providers, including UCSF, to bid on the contract to operate the DPH outpatient dialysis services which will be located at Laguna Honda Hospital (LHH). The move to LHH will enable the DPH to expand the number of outpatient dialysis chairs serving its patient populations.
